After 30 days, the Town may exercise its right to destroy, keep for Town use, donate to charity, or sell the property at public auction.							
ANY PERSON WHO BELIEVES ANY OF THE PROPERTY LISTED was stolen and may rightfully belong to him must make a claim by contacting the Gilbert Police Department Property & Evidence Section, 480-635-7166, Monday - Thursday 7:00 a.m. to 5:30 p.m. Claimants must possess and show valid photo identification.							
Owners that choose to claim their firearms must pass an extensive background check before firearms can be released.
