Backflow Assembly Installation Permit

EXISTING containment and internal backflow assemblies that are irreparable due to component failure and/or damage are required to obtain a **Backflow Installation Permit**.

***STOLEN BACKFLOW ASSEMBLIES ARE EXEMPT FROM THE PERMIT PROCESS**

Construction Permit Application will be required for all existing backflow assembly installations that fall under the criteria listed above. Multiple backflow replacements can be placed under one permit per job site. Backflow Installation Permit can be obtained at:

Type in One Stop Shop in search and proceed with the prompts. Login or register an account to begin.

The cost of this permit will be **\$93.00** and can be paid by credit card.

Excluded from the requirement of a backflow installation permit are:

New construction, tenant improvements, and STOLEN BACKFLOW REPLACEMENT.

TOWN OF GILBERT CUSTOMER CHECKLIST FOR BACKFLOW PREVENTION ASSEMBLY INSTALLATIONS

The customer is responsible for arranging for both the installation and testing of the backflow prevention assembly. The installation is to be performed by a contractor licensed with the Arizona Registrar of Contractors office.

The following checklist will assist the customer in the backflow assembly installation process. Permit is required for irreparable, and damaged backflow assemblies only.

1. Obtain and complete the Backflow Assembly Installation Permit Application and payment.
2. Obtain a copy of the Town of Gilbert standard installation detail pertaining to your installation type.
3. Obtain the list of recognized backflow assembly testers. (Call for updated list).
4. Complete the installation of the assembly.
5. New backflow assembly shall be tested by a Town of Gilbert recognized backflow assembly testing company. The tester will provide the customer and the Department with a copy of the test results.
6. Call for an inspection. Distribute a copy of the backflow test result(s) to the inspector. Email to: togbackflow@gilbertaz.gov
7. If your initial inspection **Failed**: Make any required corrections noted by the inspector on the "inspection correction notice" and re-call for re-inspection.
8. **Approved** inspection: Project complete.
