

## TOWN OF GILBERT NOTICE OF PARKWAY IMPROVEMENT DISTRICT BUDGET AND ASSESSMENTS 2016-17

The common areas and rights of way within your subdivision are maintained through a special assessment district known as Parkway Maintenance Improvement District (**PKID**). Special assessment district costs are added to your property tax bill each year on a per lot basis.

Your annual meeting was held in October to answer questions on current projects, review costs for completion of projects and receive potential ballot suggestions. At the meeting, updates were provided on the current renovation of the basin.

With no upcoming projects, your base maintenance assessment is noted below and will begin after July 1, 2016.

## **Improvement Options**

As discussed at the meeting, the amenity options for the Riata St are as follows:

- Playground \$55,000-\$65,000
  - o Removal of DG from area
  - o Installation of new bench, play structure and wood fiber
  - o Playground structure to be selected at a later date
  - o Integrated shade would be included
- Ramada \$30,000
  - o Installation of a 16 x 16 ramada with concrete
  - o Includes BBQ grill, picnic tables and trash receptacle

The monthly assessment of approved improvements would be added to your base maintenance assessment when completing the project. This is a non-binding ballot and is just gauging community interest. We would send a formal ballot out with pricing at a future date.
