# **BACKGROUND/DISCUSSION**

Parkway Improvement Districts exist in 11 residential subdivisions to provide for maintenance of improvements in common areas. Gilbert established all but one of these special taxing Districts in 1988, almost 20 years ago. Arizona Statutes require that any maintenance or improvements in the Districts be done in accordance with the plans and specifications prepared by the developer ("Original Plans"). The Original Plans are outdated and it was not practical or desirable to continue using the Original Plans.

Therefore, Gilbert retained a Landscape Architect to prepare New Plans for proposed new parkway improvement districts (with the same boundaries as the existing districts). The plans were developed with the assistance of interested residents at neighborhood meetings. The New Plans provide for replacement of irrigation systems, new landscaping, other improvements, and maintenance of common walls. The New Plans and cost estimates are on file with the Town Clerk's Office.

On August 21<sup>st</sup>, 2007 Council adopted Resolutions of Intent to create the following new improvement districts in the following residential subdivisions: PK 07-4 Spring Meadows; PK 07-9 Morning Ridge; and PK 07-11 Cassia Place. The Council has already adopted Resolutions Ordering Improvements for four of the districts and it is anticipated Resolutions of Intent will also be adopted for the remaining four districts.

Following adoption of the Resolutions of Intent, notice of adoption of the resolutions was published in the newspaper and notice of the proposed new improvements was posted in the proposed new parkway improvement districts, as required by law. The deadline for submitting protests and objections was established as September 14, 2007.

State law requires a public hearing on protests against the proposed improvements (A.R.S. § 48-579.A, B), and a public hearing on objections to the extent of the district (A.R.S. § 48-579.C). On October 1, 2007, a letter was mailed to the resident who filed a protest and objections notifying them of the hearing date. Notice of the public hearings was published in the Tribune newspaper. One protest to the improvements for Cassia Place was received. No other formal protests or objections were received.

At the public hearing on the protest to the improvement, the Town Council is required to hear and consider any protests. If the owners of a majority of the frontage of the property fronting on the proposed improvement, or the owners of a majority of the frontage of property contained within the limits of the district file a written protest against the improvements within

the time provided by law, then this written protest shall bar any further proceedings in making the improvement for at least 6 months.

At the public hearing on the objections to the extent of the district, the Town Council is required to hear and pass upon any objections. If objections to the extent of the district (the boundary) are received, the Town Council may modify the extent of the proposed district, in which case a new resolution of intent with the modified district boundary must be adopted.

Copies of the protests and objections received are attached, and are tallied as follows:

Based upon the above, insufficient protests were received to halt improvements. Gilbert did not receive objections to the extent of the district.

#### FINANCIAL IMPACT

The property owners in the Districts will bear the financial impact related to installation and maintenance of improvements in the Districts as called for in the New Plans. Each District will determine when improvements are made and how much is budgeted on an annual basis. The budgets for FY08 were adopted on May 22, 2007 and a tax levy was approved on June 19, 2007. Following adoption of the Resolutions Ordering Improvements, the work for Phase 1 of the New Plans will be publicly bid. Cassia Place will not order any improvements until FY09.

## STAFF RECOMMENDATION

Staff recommends adoption of the Resolutions Ordering Improvements to allow the new parkway improvement districts to proceed with necessary and requested improvements.



Dear Mrs. Templeton;

This is in regards to Council Resolution Number 2811 and the subsequent posting of two signs going into Cassia Place, Park Village Unit VI.

Our lot number is number 40 in the original plat, number 30903796 in the postal and 1556 East Harvard Ave as the street address. Our frontage is a nominal sixty (60) feet, with no common walls adjacent to the improvement district.

My concerns or protests are as follows:

A. Our neighborhood is currently PKID-92-01, with the common areas deeded to the Town at the inception of the PUD. What is the status of 92-01 with the creation of PKID 07-11? Do we have two districts? Two tax obligations?

- B. The posted signs state that the Improvement District is 07-02. Obviously, there is an error between the documents, PK 07-11, and the signs. Also, there are four entries into Cassia Place, but only two are posted as of today. Half of the neighborhood could exit or enter without becoming aware of the Town action.
- C. There is a current budget for PKID-92-01, valid through June 2008. There are no dates in Resolution 2811 that give effective dates for PK 07-11.
- D. Section 2 of the Resolved approves estimates of costs and expenses for approved plans. In my request to the Town Clerk, on Friday, September 7, I was not provided with the plans and estimates, even though I purchased a copy of Resolution 2811. In my experience with resolutions, it was mandatory that dollar amounts and proper reference to Exhibits be included in the Resolved. How else would you know what is included?

I am not pleased with the methods that the Town has used in this matter.
