Dear PKID Property Owner,

The common areas and rights of way within your subdivision are maintained through a special assessment district known as a **Parkway Maintenance Improvement District (PKID). Your neighborhood is: PKID 07-02 – Templeton Place.** Special assessment district costs are added to your property tax bill each year on a per lot basis.

Your PKID annual meeting was held in November 2018, to answer questions, clarify information, identify and discuss required maintenance items and receive potential ballot suggestions. At the meeting, staff discussed the current assessment costs and presented information and cost estimates for the following **Potential 1-Year Projects**:

• Potential Project 1 - Repair and Paint the Common Area Walls Engineer's Cost Estimate = \$34,776.00

The project would include stucco repair and repainting of common area walls along Cooper, Nunnely, and 130th Street, as well as a few interior walls. Minor repairs would be done for small cracks and water damage. If extensive repairs are needed, that would be part of a separate and additional project.

• Potential Project 2 – Install Reduced Scope Lighting Along Perimeter of the Park Engineer's Cost Estimate = \$86,434

This would include 27 old poles and lights being removed and replaced with 22 new poles and lights spaced 75 feet apart along the parks perimeter. The existing lights are 30 years old and it is hard to find replacement bulbs. The new poles are vandal-proof and similar in height to the existing lights. This would be considered a long-term investment project.

• Potential Project 3 - 130th Street - Enhancements to Streetscape Project Engineer's Cost Estimate = \$45,655.00

Location is the landscape strip east of the property wall on 130th Street. The irrigation system would be replaced, new plant material installed, and the old plants taken out, with healthy trees to remain.

The residents in attendance had no additional items they wished to see placed on a ballot to be voted on by the homeowners for the upcoming FY2019-2020. However, next year there may be ballot items for your consideration based on ideas received at the next Annual Meeting.

The following is a breakdown of your monthly Base Assessments and any potential project costs. Potential project costs will only be added to the Base Assessment if approved by a majority vote of the PKID 07-02 Templeton Place property owners. Assessment costs begin after July 1, 2019.
