Dear PKID Property Owner,

The common areas and rights of way within your subdivision are maintained through a special assessment district known as a **Parkway Maintenance Improvement District (PKID). Your neighborhood is: PKID 07-08 Circle G Ranches VII.** Special assessment district costs are added to your property tax bill each year on a per lot basis.

Your PKID annual meeting was held in November 2018, to answer questions, clarify information, identify and discuss required maintenance items and receive potential ballot suggestions. There were no ballot items voted on by PKID 07-08 Circle G Ranches VII, for the past Fiscal Year: FY2018-2019. At the meeting, staff discussed the current assessment costs and presented the following:

Update on the Phase 2-Renovation to Elliott Frontage Road – Cost estimate was \$78,358.92, the Bid/Contract amount was \$55,002. The contractor expects to start the project at Circle G VII the second week of January 2019. The project includes new irrigation to the turf, trees and plants. All healthy trees will remain. The dead or struggling trees and plants will be removed and replaced. The decomposed granite will be the same color and size, as the rest in the median. No grass will be removed on Elliott. There will be new irrigation drips for the plants and trees along the wall between the sidewalk and the homeowner walls.

Based on input from property owners in attendance at the annual meeting, it was requested that the ballot would reflect the following option for a vote by the homeowners. If approved, staff will research the costs for the potential project to be discussed at next year's annual meeting.

• Research ONLY - Cost to enhance the monument lighting at the neighborhood entry.

The following action items were noted from the meeting minutes for the PKID Staff to address:

- The PKID Team will research if a "No Soliciting" sign can be installed at the community entrance.
- The PKID Team will research who holds jurisdiction on the dirt path from Voyager to the power lines for possible improvements in the future.
- The PKID Team will research who holds jurisdiction at the SRP gate along the easement. Rick will have someone clean-up the landscaping in the area.
- Roof Rat prevention and extermination tips and Bulk Trash information will be included in the annual mailing.

The following is a breakdown of your monthly Base Assessments, which will begin after July 1, 2019.
