# 8. Board Assignments

Chair Presmyk discussed the need to develop a strategic plan for the Board to set 3-year plan and goals. The next meeting will be 2 hours for the brainstorming. Board subcommittees were discussed including marketing. He does not want the Board to duplicate programs and services already available in the East Valley. The Board can assist in communicating what is available and determine what may be missing. Veterans Day Committee is well established and does a great job. Member Bartram asked if we have a mission and vision.

Chair Presmyk discussed that this will be part of our brainstorming as well as reviewing bylaws.

Staff Liaison Shaffer will send out contact information for Board Members.

Member Lykins also asked for contact information of those that applied.

Councilmember Spence recommended that all ideas for future meeting topics should go through the Chair.

Member Rosenfeld will work with Mike Leppert for lists that are collected from the annual Veterans Day Ceremony to send an introduction of the Board.

Councilmember Spence has talked with Chandler contacts who would like to partner with Gilbert on an East Valley Coalition for Veterans.

Member Rosenfeld discussed Drop Zone, an event that provides health and mental health resources to Veterans. It was supposed to be held in Gilbert but was cancelled due to COVID. Gilbert can be more involved and support the event.

Chair Presmyk encouraged the group to be involved in Honor Flight. He appreciates the Board members willingness to serve.
