

Cactus Yards Sports Complex Field Request Information




Thank you for your interest in hosting your tournament at the Cactus Yards Sports Complex operated by Gilbert, AZ. For more information on Cactus Yards, please visit our website.

Please carefully read all sections of this field request.

Requests

All field requests will be accepted from recognized and qualified tournament promoters. Gilbert will review all requests received by the deadline date. Priority will be given to promoters who have a continuous proven track record of success with Gilbert and meet the criteria set forth within this document (which is subject to change). At least two References, one of which should be another municipality, should be included with any date requests from promoters that are new to Gilbert. Be sure to include any additional data regarding the tournament that might aid Gilbert's decision-making process.

Field requests will be accepted from independent and association promoters. Members of associations should submit their date requests through their director unless prior arrangements have been made with Gilbert. Association directors are encouraged to copy this information to all their promoters so they may be made aware of the Gilbert requirements.



2024 Field Requests will be received until 7/31/2023. Applicants will receive notification of results in August/September. Requests received after 7/31/2023 will still be reviewed based on date availability for the request in question. The list below is criteria that Gilbert will consider when accepting tournament requests. This list is not all inclusive and is subject to change.

- In continuous good standing with Gilbert
- Commitment to utilizing Gilbert hotels
- Number of participating teams
- Experience working with Gilbert
- References provided and/or sought out by Gilbert
- History of Tournament and/or applicant

- Local, regional, national draw
- Number of guaranteed games
- Estimated tournament attendance
- Number of guaranteed weekends
- Professional reputation in providing tournaments
- Youth tournaments given priority

Use Agreement

Upon awarding of dates, all promoters will be required to sign a Gilbert Use Agreement. Until such Agreement is fully executed, all dates are held on a tentative basis only. This Agreement will include possible field restrictions for the awarded date, souvenir sales restrictions, deadlines for getting information to the Sports Complex Supervisor regarding game times, minimum field guarantee, insurance, deposit, etc.

Insurance Requirements

One of the contractual requirements is for the association/organization to maintain insurance for all events it hosts at Cactus Yards Sports Complex. Evidence of this coverage will only be accepted in the form of a Certificate of Insurance. A copy of this certificate must be on file at our headquarter office no later than thirty (30) days prior to the event. The minimum requirement is \$2 million dollars general liability coverage with participant coverage. Gilbert must be named as additional insureds as follows:

Blackout Dates/Limited Availability

Some dates are not available or have limited availability due to league commitments, Gilbert events and maintenance periods. Requests for blackout and limited availability dates will be accepted and considered on a space available basis.

Field Rental Rates and Minimums

The field rental rates and minimum number of games for each facility and holiday weekend requests are as follows:

Date requests for tournaments that do not meet the requirements for the minimum number of games below will be accepted and considered on a secondary basis. Each field rental comes with the fields prepped and ready for play each day of the rental period.

The minimum rental is the amount of field rental that would be due based on the minimum number of games. Special consideration will be given to bids that offer a higher minimum rental or per game rate over the course of several date requests.

The minimum number of games for dates with restricted availability will be set in the Use Agreement.

Field rentals, payment terms and souvenir sales commissions due dates and details will be included in the Use Agreement.

All promoters are subject to deposit prior to the event with specific details to be covered in the Use Agreement.

Tournament Souvenir Sales, Vendors and Sponsors

Gilbert reserves the right to not allow souvenir sales, outside vendors or tournament sponsors on any event. Promoters may operate tournament souvenir sales that comply with Gilbert's Code and Policies & Procedures, which are subject to change, and will be addressed in the Use Agreement.

All tournament sponsorships must be approved prior to the tournament to avoid any conflicts with existing Gilbert partners. Field rental rates do not include display/merchandise rights for a tournament sponsor. All sponsorship participation must be approved at the time of the Use Agreement signing and are subject to additional charges.

Host Hotels

Tournament promoters using Gilbert's Cactus Yards Sports Complex may not promote the use of any hotel not located within Gilbert municipal boundaries unless by prior written approval by Gilbert. More details are available in the Use Agreement.
