The HHW Facility has been visited over **128,215** times.

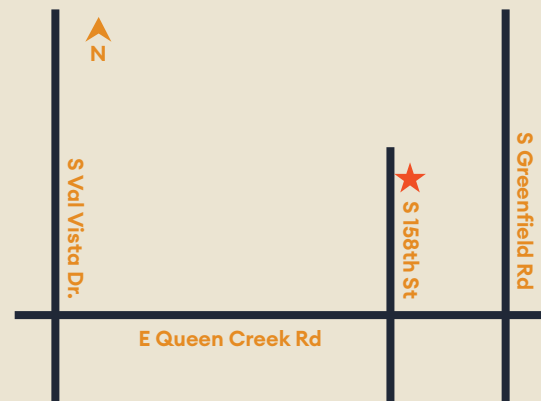


The HHW Facility has taken in more than **7.7 million** pounds of household hazardous waste.

## ✓ Acceptable Items

Gilbert residents can safely dispose of many household hazardous waste materials such as:

- ✓ All types of batteries
- ✓ Automobile tires without rims (5 tire limit per year)
- ✓ Automotive fuels and fluids\*
- ✓ Camping cylinders (limit 20)
- ✓ Cooking oil\*
- ✓ E-Waste: TV's (flat screen only), laptops, computers, cell phones, and printers
- ✓ Fire extinguishers
- ✓ Fluorescent light bulbs (CFL's, HID, Neon)
- ✓ Herbicides and pesticides\*
- ✓ Household cleaners\*
- ✓ Paints and stains-latex and oil based\*
- ✓ Pool chemicals
- ✓ Propane tanks
- ✓ Scrap metal
- ✓ Smoke detectors/Thermostats
- ✓ Very small appliances (without freon)

*\*There is a limit of 10 gallons of any single liquid type per day.*

## ✗ Items Not Accepted

- ✗ Business/commercial hazardous waste of any kind
- ✗ Large appliances: contact Customer Service at (480) 503-6400 for White Goods pick-up
- ✗ Electronics: CRT tube TV's, microwaves, and vacuums - place out with your bulk trash
- ✗ Automobile tires with rims
- ✗ Explosives and Ammunition
- ✗ Medical sharps
- ✗ Prescription drugs\*\*
- ✗ Trash/Recycle (Black or Blue can items)
- ✗ Radioactive material
- ✗ 55 gallon drums of material
- ✗ No containers over 5 gallons will be accepted

*\*\*Gilbert offers 24 hour prescription drug dropoff boxes at Gilbert Police Department Lobby at 75 E. Civic Center Drive*

### What to Bring

This facility is open to Gilbert residents who pay a utility bill only. Residents must bring a drivers license with Gilbert address and recent utility bill.

## Come Visit Our Swap Shop



Many of the materials dropped off at Gilbert Household Hazardous Waste Facility are usable products. Distribution and reuse of these products is a positive alternative to disposal. These useful products are available at no cost to the public and are not for resale. Stop by and check it out - you do not need to drop off to shop.

These items are available on a first come, first serve basis and cannot be reserved.

The HHW facility offers 5 gallon buckets of tan and gray recycled latex paint to the public for personal use through our paint reuse program. Limits may apply.

## Safety Precautions to Follow:

- Do NOT mix different materials together in the same container
- Keep products in original containers with legible labels
- Place containers in cardboard boxes or plastic crates with lids securely fastened to transport safely
- Do NOT use plastic bags
- Keep fluorescent light bulbs separate from other items
